## Liz Wiley (Marion Institute):

- Can we get an update on the culinary center from you Rob?

### Rob Shaheen (New Bedford Public Schools):

- On March 1 New Bedford is getting more students back not every school, not every grade
- Grab n'go lunches are still going, 8 sites every day
- We have to shut down 1 high school in order to construct the culinary kitchen, which will act as central kitchen project is scheduled to finish on June 30<sup>th</sup>, 2021
- We received the Infrastructure Food & Security grant from the state, amounting over \$1 millionproject costs \$3.2 million

### Victoria Grasela (United Way of Greater New Bedford):

- We got fish chowder we still have 1 pallet left, if anyone's interested
- We started pop-up winter mobile markets, we had one this past Wednesday, we served over 100 households in less than 1 hour 340 people benefited
  - Pasta, stuffing, soup, fresh produce from the Y
- On Tuesdsay we'll be in Wareham from 5:30 end of supply, on Bank 5 on Acushnet on Wednesdays
- USDA Food boxes have been going ok from what I know
  - o Next Saturday is the last one for now

 The idea to use the schools' all calls system is a great one – Tom Scott the head of all superintendents through the commonwealth – we can put it on all the school websites, we could hit it all across the state

#### Pam Kuechler (PACE):

- We also have an all call system that we use for our client data base
- We get referrals from Neighborhood Housing Solutions when people in Fall River and New Bedford reach out for RAFT
- It'd be more impactful if we did this in a more organized, intentional way as a group
- We're getting additional funds that go outside of RAFT or ESG to help people who don't qualify
- The key is to help people now, before the eviction moratorium is over to prevent homelessness

- I'm happy to work with the Wareham school system

#### Pam Kuechler (PACE):

- We'll try and get something together in the next week that we can get out to people
- We closed on our new building last week and will be making renovations
  - We'll do a mobile market pantry the week after next, at least 1 day a week

  - Perhaps a farmer's market
  - We have a lot of space; we're at 477 Park St., New Bedford
  - We will potentially do something with Elliot Farm
