Land Acknowledgement

We acknowledge that this land is the traditional unceded territory of the Wapanaak (Wampanoag). Pre-English invasion, this place, its gifts of fertile soil, waters, wildlife and beauty, had already sustained Indigenous tribes for 12,000 years. We honor and respect the precious food sources discovered, harvested and cultivated by Native peoples and remain grateful to them for their connectedness to this land and their food traditions. 
Initiatives:
